Memorials in the Garden of Rest are of a standard design and must be ordered through the Town Council; they can only be placed on grave spaces where the holder of the Exclusive Right of Burial has given permission.

Orders for memorials can be made at the same time as the interment is requested by completion of the information in the table below.

It is possible to have a tablet and a vase on the same plot.

Additional Information

Wherever possible, please provide a minimum of 3 working days' notice for any interment request. Any change notified or incomplete information may result in a delay and additional charges.

Where an Exclusive Right of Burial is in place we must have the signature of the owner of the burial rights as per the Local Authorities Cemeteries Order 1977. It may be necessary to transfer the ownership of burial rights before an interment can be agreed.

Permission must be given by North Petherton Town Council **BEFORE** any headstone is removed.

A Memorial Request must be submitted and approved **BEFORE** a memorial is installed or altered.
